\_\_\_\_\_ Calculations: building length and area of existing signs on building or property. Total area of all signs shall not exceed one square foot for each linear foot of the front of the building.

Side yard or first two-thirds of front yard*	Less than 6	25
Side yard or first two-thirds of front yard*	6 to 10	12
Beyond first two-thirds of front yard	No more than 10	50

\* In PR and BR Zones: within 43.3' of front property line; in C1 Zone: within 26.7' of front property line; in B1 and B2 Zone: within 13.3' of front property line.
