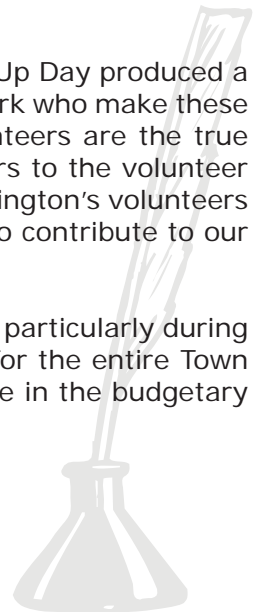

***STORMWATER RUNOFF POLLUTION: PET WASTE***

Pet waste left in our yards and communities can have many adverse effects on the environment, as it is full of harmful bacteria and excess nutrients. Besides the fact pet waste is a neighborhood nuisance, it can make people sick, especially children who are more likely to come into contact with it while playing. Pet waste left on lawns can also kill or damage grass and other plants. When you fail to clean up after your pet, the waste left on sidewalks and lawns is both unpleasant and a nuisance. But it can become an even bigger problem when it rains and is carried by stormwater into nearby rivers, lakes and streams. When pet waste is washed into lakes or streams, the waste decays, uses up oxygen degrading water quality and affecting fish. It also contains nutrients that encourage weed and algae growth.

Here are some things *"You Can Do to Prevent Stormwater Runoff Pollution"*:

1. Pick up after your pet. Pet waste can be a source of bacteria, and can lead to contamination of wetlands, streams, lakes, and rivers.
2. Pet waste should NOT be composted even in a biodegradable bag.
3. Dispose of cat litter in the trash. NEVER flush cat litter down the toilet or compost it.
4. BRING IT - Always bring a plastic bag when you walk your dog. Put bags in the car or tie them to the leash, so you'll be prepared when you travel with your pet. Place bags by the door so you don't forget them.
5. BAG IT - Use the bag as a glove to pick up the pet waste. Scoop up the waste and turn the bag inside out around the waste.
6. DISPOSE IT - Properly dispose the waste by placing it in a trash can or flushing it unbagged down the toilet. NEVER THROW WASTE DOWN A STORM DRAIN!
7. Talk to your family and friends about stormwater pollution and picking up after their pets!
8. WASH YOUR HANDS!!!

The Town of Farmington is happy to announce that we are working with the Towns of Avon, Canton, Granby and Simsbury to provide Household Hazardous Waste Collections. The collections will run from 8:00 a.m. to 1:00 p.m. and will be open to all residents from Avon, Canton, Farmington, Granby and Simsbury. Farmington residents will no longer be able to participate in any of the MDC household hazardous waste collections.

There will be three (3) collection dates that Town of Farmington residents can attend:

- April 21, 2018 – at Farmington High School, 10 Monteith Drive, Farmington, CT.
- June 9, 2018 – at Simsbury Public Works Facility, 66 Town Forest Road, Simsbury, CT.
- November 3, 2018 - at Simsbury Public Works Facility, 66 Town Forest Road, Simsbury, CT.

On the same dates and locations listed above, there will also be FREE collections of Electronics and Used Motor Oil for the residents of Avon, Canton, Farmington, Granby, and Simsbury.

Below are some frequently asked questions related to Household Hazardous Waste disposal. For more specific information, please contact Farmington Highway & Grounds at 860.675.2550.

**Acceptable items:**

- ☺ Fluorescent and compact light bulbs
- ☺ Batteries – common household batteries including rechargeable batteries & car batteries
- ☺ Lawn care chemicals – fertilizers, pesticides, herbicides, fungicides
- ☺ Switches or items containing Mercury – thermometers, thermostats, motion detectors
- ☺ Household cleaners – acids, adhesives, aerosol cans, ammonia, drain cleaner, disinfectants, moth balls, etc.
- ☺ Chemicals from the garage or workshop – antifreeze, ant/bug spray or bait, brake fluid, old gasoline, oil based and latex paints, lighter fluid, polyurethane, pool chemicals, road flares, transmission fluid, power steering fluid, wood stain, etc.

Starting 7/1/13, a Connecticut Law requires the paint and coating industry to develop a financially and environmentally sustainable solution to manage postconsumer architectural paint. Under the new program, the paint industry will make paint recycling more convenient by setting up drop-off sites throughout the state where consumers can take their paint. *PaintCare* will also conduct outreach and education about buying the right amount and using up remaining paint. **REMINDERS FROM THE ASSESSOR'S OFFICE**

**ELDERLY/TOTALLY DISABLED AND VETERANS TAX RELIEF PROGRAMS**

**NEW AND CONTINUING DEVELOPMENTS**

Applications for the Elderly and Totally Disabled State and Town Homeowner programs are available in the Assessor's Office through May 15, 2018. Applicants must be 65 years of age by December 31, 2017 or totally disabled, no age limit, to qualify. Income levels for the State program cannot exceed \$35,300 for a single person and \$43,000 for a married couple. The Town program income limits are \$41,300 for a single person or \$49,000 for a married couple. You may download an application from the Town of Farmington website; go to the Assessor's Page, under "FORMS", or you may come to the Assessor's Office in the Town Hall. Please be sure to bring your Federal Tax Return, if you file one, and your Social Security Statement (SSA 1099) when applying. If you do not file a tax return, you must provide proof of all forms of income, including your 1099 statement, pension benefits, interest, dividends, etc.

The Veterans Program requirements are the same as the elderly programs. However if the applicant is 100% disabled, the income maximum is \$18,000 for a single person, and \$21,000 for a married couple, *excluding* Social Security.

2017 was a very busy year for the Assessor's Office. A Revaluation Update has been completed in conjunction with Tyler Technologies/CLT. More than 3,000 properties were measured and listed. The use of a drone assisted in reviewing properties difficult to access by a physical inspection. Photos were taken of all properties in town and are now available on each property card, along with a sketch of the building(s), details of the structure(s) and land information. Real Estate values were adjusted based on a market analysis to reflect current values in this time of change. We have seen shifts in value, both increasing and decreasing, throughout town, for the residential and the commercial/industrial markets. The medical field continues to grow, as evident in the expansion of the UConn Health complex.

There has also been ongoing development in new and existing subdivisions. In addition, many building permits were issued for various residential improvements, such as room additions, garages, porches, decks, and in-ground pools, as well as activity in commercial construction reflected in both Personal Property and Real Estate.

**WATER POLLUTION CONTROL FACILITY UPDATE**

The comprehensive upgrade to the Town's Water Pollution Control Facility began in March of 2016. After 2 years of construction, many of the new process facilities are being put into service this spring, including the Ultra Violet Disinfection system. This has eliminated the use of chemicals that were previously used to disinfect the treated wastewater. The project is currently running on schedule and is nearing 75 percent completion, with \$43,034,293 paid as of February 29, 2018. The completed facility will produce a higher quality effluent with greater reliability and efficiency for years to come.



**POLICE ACCREDITATION**

CALEA stands for Commission on Accreditation for Law Enforcement Agencies, Inc. In 1979, the Commission was created through the combined efforts of four major law enforcement organizations; the International Association of Chiefs of Police, National Organization of Black Law Enforcement Executives, National Sheriffs' Association, and the Police Executive Research Forum. The purpose of the Commission is to develop law enforcement standards and to establish and administer the accreditation process. The accreditation process is how a law enforcement agency voluntarily demonstrates how they meet professionally recognized criteria for excellence in management and service delivery. The Farmington Police Department initially attained CALEA accreditation in 1992. Some of the benefits of accreditation include:

1. CONTROLLED LIABILITY INSURANCE COSTS
2. STRONGER DEFENSE AGAINST LAWSUITS AND CITIZEN COMPLAINTS
3. GREATER ACCOUNTABILITY WITHIN THE AGENCY
4. STAUNCH SUPPORT FROM GOVERNMENT OFFICIALS
5. INCREASED COMMUNITY ADVOCACY
6. IMPROVED EMPLOYEE MORALE



Since the initial accreditation in 1992, the Department has successfully attained re-accreditations in 1997, 2000, 2003, 2006, 2009, 2012, and 2015. The Department just had its ninth re-accreditation process in March of this year with a favorable recommendation from the assessment team to the Commission. In 2009, the Department was recognized as a Flagship Agency demonstrating success and achievement in the accreditation process and was awarded a Meritorious Service Award for being accredited for over 15 years. The Department in 2012 was awarded an Award with Excellence, a designation given by the Commission to those agencies that have demonstrated success in the accreditation process and have the best practices on how to address compliance, policy development, and file maintenance.

**TARGETING OPIOID USE DISORDER (OUD)**

As part of Connecticut's Targeted Response to the Opioid Crisis, the Community Service Department and Farmington FOCUS has received a grant to help prevent opioid use and overdose. While police have already been trained in the effective administration of Narcan, as part of the grant Farmington's Fire and Rescue personnel have now also been trained. In the event of a suspected opioid overdose, call 911 immediately. First responders carry Narcan, an opioid antagonist, that can temporarily reverse the effects of an opioid overdose until further medical attention can be provided.

- Be aware of signs and symptoms of OUD, including any changes in normal behavior, weight loss, small pupils, and/or disappearance of money or household items that can be sold to purchase drugs.
- If prescribed an opioid based painkiller, take only what is necessary to relieve the pain. Never take more than what is prescribed and never take pain medication longer than needed.

**PRECAUTIONARY MEASURES AGAINST OPIOID AND OTHER SUBSTANCE ABUSE:**

- Store medications, particularly those at risk for abuse, locked and away from potential theft or misuse.
- If selling a house, keep all drugs away from those who may use the bathroom while the house is being shown.

**REMINDER...**There is a **DRUG DROP-OFF BOX** located at the Farmington Police Station. The drug drop-off box is always accessible, 24 hours a day, seven days a week and is a safe way to dispose of Rx medications..

**FISHING FACTS**

There is a new regulation as of this year's fishing

season requiring a trout stamp. Frequently asked questions regarding the new Trout Stamp can be found on the Fisheries Web page at [www.ct.gov/deep/fishing](http://www.ct.gov/deep/fishing) or by phone at 860.424.FISH. The stamp has a fee of \$5.00 (\$3.00 for CT residents age 16-17) and expires at the end of each calendar year.

A Trout Stamp is required for anyone age 16 or older, including those age 65 and over who:

- Harvest trout, Kokanee, or Salmon (except as described in 26-48c)
- Fishes in one of these four trout/salmon areas: trout management areas, wild trout management areas, trout parks or broodstock Atlantic salmon areas.

Opening day for fishing is April 14, 2018 by the State of Connecticut Department of Energy and Environmental Protection. Licenses are available online from the Connecticut Department of Energy and Environmental Protection [www.ct.gov/deep/fishing](http://www.ct.gov/deep/fishing) and at the Town Clerk's office.

**ABSENTEE BALLOTS FOR FALL**

The date of the Gubernatorial Election this fall is November 6, 2018. College students and anyone that will be out of town at election time are encouraged to fill out their absentee ballot applications before leaving town. The budget as recommended by the Town Council is on file and available for public inspection in the office of the Town Clerk.

"2. SHALL THE TOWN OF FARMINGTON APPROPRIATE \$650,000 FOR ACQUISITION OF A PUMPER FIRE ENGINE TO BE STATIONED AT THE TUNXIS HOSE FIRE STATION AND AUTHORIZE THE ISSUANCE OF BONDS AND NOTES IN THE SAME AMOUNT TO FINANCE SAID APPROPRIATION?"

"3. SHALL THE TOWN OF FARMINGTON APPROPRIATE \$1,935,000 FOR VARIOUS SCHOOL FACILITIES SECURITY AND INFRASTRUCTURE IMPROVEMENTS AND AUTHORIZE THE ISSUANCE OF BONDS AND NOTES IN THE SAME AMOUNT TO FINANCE SAID APPROPRIATION?"

"4. SHALL THE TOWN OF FARMINGTON APPROPRIATE \$1,995,000 FOR VARIOUS SCHOOL ROOF REPLACEMENT PROJECTS AND AUTHORIZE THE ISSUANCE OF BONDS AND NOTES IN THE SAME AMOUNT TO FINANCE SAID APPROPRIATION?"

Resolutions adopted by the Farmington Town Council at a meeting held April 2, 2018, and to be presented and discussed at the Annual Town Meeting to be held Monday, April 16, 2018, shall be submitted under the ballot headings above to vote on voting machines of persons qualified to vote in town meetings of the Town of Farmington on Thursday, April 26, 2018, between the hours of 6:00 a.m. and 8:00 p.m. in conjunction with the referendum on the Fiscal Year 2018-2019 budget to be held on that date.

If approved, resolution #2 will appropriate \$650,000 and authorize borrowing for costs related to acquisition of a pumper fire engine to replace Engine #2 at the Tunxis Hose Fire Station, and related equipment.

If approved, resolution #3 will appropriate \$1,935,000 and authorize borrowing for costs related to various school facilities security and infrastructure improvement projects, and related work and improvements, contemplated to include relocation of the main offices at Noah Wallace School, and West District School; installation of security vestibules at East Farms School, Union School, West Woods Upper Elementary School, and Irving A. Robbins Middle School; mechanical control upgrades at East Farms School, Union School, and West Woods Upper Elementary School; wiring upgrades and limestone façade repair and replacement at Union School; chiller replacement at West Woods Upper Elementary School; replacement of the heat loop at West District School and replacement of the air handling units at Irving A. Robbins Middle School.

If approved, resolution #4 will appropriate \$1,995,000 and authorize borrowing for costs related to various school roof replacement projects, and related work and improvements, contemplated to include replacement of the K, N, O and 1959 sections of the Irving A. Robbins Middle School roof, replacement of the Union School roof, and replacement of the O,Q,R, and U sections of the Farmington High School Roof.

The full text of each resolution as approved by the Town Council is on file and available for public inspection in the office of the Town Clerk.

Electors shall vote at their regularly assigned polling places, as follows: Electors residing in the First Voting District and assigned to polling places 1-1, 1-2, 1-3, and 1-4 shall vote at Irving A. Robbins Middle School, 20 Wolf Pit Road, Farmington, Connecticut; and those assigned to polling place 1-5 shall vote at West Woods Upper Elementary School, 50 Judson Lane, Farmington, Connecticut. Electors residing in the Second Voting District and assigned to polling place 2-6 shall vote at the Community & Senior Center, 321 New Britain Avenue, Unionville, Connecticut; and those assigned to polling place 2-7 shall vote at the Municipal Complex, Monteith Drive, Farmington, Connecticut. Voters qualified to vote at town meeting who are not electors shall vote at their respective polling place at Irving A. Robbins Middle School, West Woods Upper Elementary School, the Community & Senior Center or the Municipal Complex. Absentee ballots will be available from the Town Clerk's office.
